Shoal Creek-Rosedale Storm Drain Improvements Project Update

Highlights

- We have completed the base layers of the new pavement for most of the project area. This should provide a better driving surface until we are able to finish the repaying.
- We have decided to replace the water line on 42nd Street be-
- tween Burnet and Rosedale. While we were working on 42nd Street, we noticed this water line was deteriorating. Replacing it now will help to prevent leaks as well as the potential for more construction in the future should the line fail.

• We still need to connect the new water lines on the streets surrounding the park. When

the connections are made, we will need to turn the water off. We will leave notices at your homes or businesses 48 hours in advance. Please keep an eye out for these notices in the coming weeks.

• Please note that the original construction inspector, Travis Miller, has returned to this project. His contact information is at the bottom of the email.

Completion of Project and Staging Area

Most of the work on this project has been completed, but the few remaining items will likely not be finished by the end of June as originally planned. Two issues have delayed project completion. One is the addition of the water line on 42nd Street. The other is the water line work on Medical Parkway near 42nd Street. We are pushing to complete these tasks as soon as possible and want to thank everyone for their patience. We would like to return Ramsey Park to the neighborhood as soon as possible and are looking into other possible staging areas for the remainder of the work. (Note from RNA: June 27 is the target date for moving the staging site per meeting with RNA representatives June 12).

Remaining Work

- A water line and inlets on Medical Parkway near 42nd Street.
- Replacing the water line on 42nd Street.
- Work on the water line on 44th Street near Medical Parkway.
- Connecting the new water lines on the streets near Ramsey Park. After this is completed, we will install the last remaining inlets on these streets.
- Re-installing speed cushions on 40th Street.
- Repaying and restoration.

47th Street

Work on 47th Street has been completed except for spot repairs to the pavement base, installing the top layer of asphalt and repaving work at the intersection of Burnet.

Ramsey Park Improvement Suggestions

The "Ramsey Park Improvement Suggestions" is a comprehensive list of all the suggestions and general comments the committee has received in response to emails, asking for ideas on how the park can be improved, and the brainstorming session. We asked you to dream big, and dream big you did! There were many, many wonderful suggestions and most revolved around a number of common themes, such as adding more shade, updating the tennis courts, and providing more seating, to name a few.

As a reminder, the city is requiring all parks to have an approved master plan before any improvements can be made. This is a new requirement, and only two parks (Brentwood and Bartholomew) have approved master plans in place. They have been kind enough to share their documents and process with us. The Rosedale Neighborhood Association (RNA) is in a unique position in that we have funds that can be used for improvements, whereas Brentwood and Bartholomew were being proactive in drafting master plans prior to moving forward with their fundraising efforts and park improvements.

The current draft of the master plan is based on feedback that was gathered, through emails and the brainstorming session. It is a high level view of the park's current functions, with a look to the future. Consequently, if we want something -- even if it is 10-15-20 years from now -- it should be included. There are elements listed that we will not be able to afford using the mitigation funds alone, or elements we may not want to allocate mitigation funds toward at this time, but still want to see incorporated into the park in the future. As funds become available either through fundraising, grants, or city bonds, these elements will already be in the master plan, and working with the city to execute our goals will be easier.

Since this is the RNA's first experience with a master plan, we are asking city staff to react to this version to see if we are on the right track. At this time, we are not asking for the city's approval of the content, we want to know if it matches the city's expectations and needs, and if the plan is lacking an important component. We are also sharing this version of the plan with you for your feedback. If you have ideas about the park that are not covered in either the spreadsheet or the master plan, please let us know at RamseyPark2012@gmail.com.

The master plan is the first of a two-step process with the city. Once it is in place, (which we will distribute again when an updated version is available), we will be working with a landscape architect and/or designer to help us draft a much more detailed "Concept Plan" for the scope of this project. The concept plan will outline specific improvements and will include a rendering. We will conduct a neighborhood survey this summer, to ascertain priorities for the specific improvements to make using the mitigation funds.

Thank you for your support as we go through what is an ongoing learning process, for us and the city. The good news is that the end of the storm drain project is in sight!

Short-Term Rentals

On June 7, the Austin City Council approved on first reading changing the City Code to allow for the commercial use of residential property. The ordinance would allow short-term rentals (less than 30 days) for up to 3% of the houses in a zip code. That would be 36 houses in Rosedale if STRs were spread evenly throughout the 78756 zip code. Rentals by owner occupants would be allowed without restriction; commercial rentals are houses bought just for the purpose of leasing them out for short term duration.

There will be other opportunities to voice your opinion by emailing the city council and attending future council meetings where the ordinance will be presented again.
